| Swimming pool: | The pool length is 25m. The swimming pool has 5 lanes, they are separated by wave-breaking lines. The water depth is 1.8 meters to 2.5 meters. |
| Date/ Time: | Friday, 10.05.2024 09:00 to 18:00h Open from 09:00, start of competition 10:00h |
| Competition rules: | <p>The competition regulations (WB Swimming), the legal regulations and the antidoping regulations of the German Swimming Association e.V. (DSV) in the current version apply.</p> <p>For handicapped persons with classification proof, the competition regulations of the German Handicapped Sports Association e.V. are to be applied additionally.</p> <p>The start signals according to §125 WB-Swimming of the DSV para. 2 - 5 ("several short whistles", "long whistle", command "Auf die Plätze" and the start signal itself) will be replaced or supplemented by optical signals. A briefing for all starters will take place before the start of the competition.</p> <p>According to § 125 Abs. 6 WB-Swimming of the DSV the competition will be held according to the one-start-rule.</p> |
| General regulations: | <p>Timekeeping will be done by hand measurement.</p> <p>With the submission of the entries the club declares that the athletes registered by them have the right to start for the club / the starting group and that the last sports medical examination of the registered athletes was not longer than 12 months ago. The reporting clubs are liable for this report. The "Special Youth Protection Rules Swimming" of the DSV apply for participants with an age of 10 years old and younger.</p> |
| Judges: | The judges will be provided by the organizer. All referees must have a valid referee license of the respective city or state swimming association of the DSV. |

Eligibility:

Eligible to participate are:

1. Swimmers with a valid German Deaf Sports Association right to start, i.e. in possession of a yellow passport or its successor,
2. Deaf members of deaf sports clubs without an association pass,
3. Members of schools for the deaf or comparable institutions,
4. Deaf members of hearing sports clubs without association pass,
5. Hearing impaired or deaf swimmers with non-German nationality,
6. Outside of any classification, hearing swimmers may compete as guests without regard to citizenship. They will neither receive medals nor will an award ceremony be held. The achieved times will be published in a separate group "out of classification" without ranking.

In case of suspicion and upon request of the competition management, deaf starters without German Deaf Sports Association starting rights must prove their hearing impairment or deafness by medical certificates.

Scoring:

Scoring will take place in two scoring circles:

1. "German Championship National" This evaluation circle includes eligible swimmers with German citizenship with the exception of hearing swimmers according to point 6 of the eligibility rules. Swimmers of this classification will be evaluated in parallel and with the same time also in classification 2 "International German Championship".
2. "International German Championships" This classification includes all participating swimmers without consideration of nationality with the exception of hearing swimmers according to paragraph 6 of the eligibility rules.

The following applies to both scoring circles:

- The scoring in Age Group E and F (age groups 2015 - 2018) will be done i.a.w. year of birth, the scoring of age groups 2014 and older will be done in the announced age groups.
- The open classification includes all announced age groups and age categories of a competition together in one classification.

The following titles are awarded:

- a) The winners of the open classification will receive the title "German Deaf Champion" or "International German Deaf Champion" of the respective competition.
- b) The winners of the age groups or year groups will receive the title "German Deaf Champion [Age Group or Year of Birth]" of the respective location.

Honors:

The places 1-3 will receive medals. All participants will receive certificates, these will be offered as a download after the end of the competition.

In the open classification "International German Championship" the most successful female and male swimmer of the event will be honored additionally. The calculation takes place according to the following rules:

- The number of 1st places is decisive for the ranking.

- In case of a tie, the number of 2nd places will decide, then the number of 3rd places and last the FINA points achieved.

Form, place and time of the award ceremony depends on the final registration result. Information about this will be given at the team meeting at the beginning of the event.

Possible changes

After the evaluation of the entry results, the order of the competitions, the course, the scoring and the form or the extent of the planned honors may be changed. The organizer also reserves the right to combine individual competitions with others or to cancel them. Information about this will be given at the team meeting at the beginning of the events at the latest.

Age classification

Names and order of the relay participants must be reported to the referee 5 minutes before the start of the respective relay competition.
